With her graduate student co-authors Janna Ferguson, Grace Howard, and Amanda Roberti, she is the author of *Informed or Misinformed Consent? Abortion Policy in the United States*. The study analyzed statements about embryological and fetal development from information booklets produced by 23 states that
